Sub: 2x660MW Thermal Power Plant along with a cement grinding unit at village Nigri, in Tehsil Deosar, in District Singrauli, in Madhya Pradesh - Amendment of Environmental Clearance regarding.

Sir,

This has reference to your letters dated 02.02.2012 and 07.03.2012 on the above mentioned subject requesting for amendment of environmental clearance in view of proposed enhancement of the capacity of Cement Grinding Unit from 2.0 to 4.0 MTPA.

- 2. It is informed that your request was placed before the Expert Appraisal Committee (Thermal Power) in its 44th Meeting held during March 5-6, 2012. The Ministry in acceptance of the recommendation of the Expert Appraisal Committee (Thermal Power) hereby informed that the following amendment as mentioned under shall be made in this Ministry's letter of even no., dated 25.02.2010.
- a) In the subject matter of the aforesaid letter of this Ministry i.e letter of even no. dated 25.02.2010, the figure 2.0 MTPA shall be replaced by 4.0 MTPA.
- b) At para no.2 of the aforesaid letter of this Ministry i.e letter of even no. dated 25.02.2010, the figure 2.0 million TPA mentioned in the first line shall be replaced by 4.0 million TPA.
- 3. After clause no. (xxxviii), under Para no.4 of this Ministry's letter of even no. dated 25.02.2010, the following conditions shall be now added:

(xxxix) Bag house and dust suppression shall be installed in packing area to control the particulate and fugitive emissions.

4. All other conditions stipulated in this Ministry's aforesaid letter of even no. 25.02.2010 shall remain the same.
